2.6 Brief explanation of figures 2.1 to 2.4

Net results for the year amounted to a loss of \$247,577 attributable to the members compared to a loss of \$258,862 for the same period last year.

Operating costs of the company have consisted mainly of consulting geologists' fees, Directors fees, accounting and audit fees, legal expenses and listing costs.

During the financial year, the company explored its interests in mining tenements located in Western Australia. The 100% owned Lyndon gold, silver and copper prospects are located in the Gascoyne Region, approximately 300 km northeast of Carnarvon. Four contiguous granted tenements of 652 km² contain a cluster of high grade workings dating back to the 1950's that have never been drilled at depth nor explored by modern techniques.

Work undertaken during the year included reverse circulation (RC) drilling at the Lyndon Bettina, Broken Thumb, Thirty Bob and Skarn prospects, followed by geophysical surveys at Lyndon Bettina and Broken Thumb.
